Association Mission: Focus

Existing Mission:

- The mission of the BWVRA is to foster a well-balanced and livable community, and to support and encourage participation of all residents in setting and meeting these goals
 - ▶ Engage residents, businesses and others on issues specific to Bloor West Village
 - Provide a liaison with and seek support from all levels of government
 - Promote a safe and healthy neighborhood environment
 - Promote the quality of life that reflects the unique character of the local community
 - ▶ Participate, through the most effective means, in the planning of new development as well as redevelopment opportunities that reflect the values of the local community
 - ▶ Share information with residents, businesses and other interested members of the community.

Continued Direction:

Renewed focus to liaison with the local councilor on items including the street scape and tree canopy, and working more closely with neighborhood organizations

Association Bylaw: Revision In Process

- Revising Association bylaw to comply with Ontario Not-for-Profit Corporations Act, 2010 (ONCA)
- Still working on this, apologies for delay, had hoped to have ready for AGM
- Reviewing current Letters Patent (2013) and bylaw using assessment tools and resources from nonprofit sector (e.g., Community Legal Education Ontario/Nonprofit Law Ontario)
- ▶ ONCA provides a more modern regulatory regime for not-for-profit corporations, e.g.,
 - Enhances rights of members
 - Increases protections for directors and officers
 - Limits financial review requirements for organizations with low revenues
- Our current bylaw amenable to revision to ONCA requirements
 - ▶ It was drafted when ONCA was adopted but not yet proclaimed and in force
 - Already reflects many concepts in ONCA but some updates and new content to add
- Will need special meeting of members by mid-August 2024
 - Adopt restated articles of incorporation (for refiling with province to replace our 2013 Letters Patent)
 - Adopt ONCA-compliant by-law revisions
 - ► Complete transition to ONCA by October 18, 2024 deadline

Year In Review: Development & Policy

Development Update

- ▶ Humber Theatre build in process. Active construction of site
- ► Harcroft & Bloor build NOT in process. The City is still waiting to hear from Developers

Avenue Study & Heritage Conservation District (HCD) Study

- ▶ Toronto Planning provided an update to the Local Advisory Committee on May 8, 2024
 - Noted changes in planning framework since 2018 (e.g., provincial policies, density around transit stations)
 - ▶ Updated on Draft Urban Design Guidelines (density opportunities, revised mid-rise building massing)
 - ► Heritage Conservation District (HCD) Study (potential heritage property designations, pursue heritage character through design guidelines instead of an HCD)
- Next steps (main ones)
 - ▶ Status report to Council in Q2/Q3 2024, report on Official Plan and Zoning amendments in Q4, 2024
 - ► Consultation with stakeholder groups in Q3/Q4 2024
 - Report to Toronto Preservation Board on HCD in Q4, 2024
